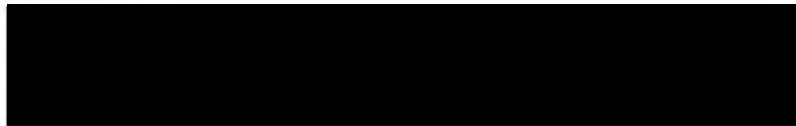

**NOTICE OF INTENT TO CIRCULATE RECALL PETITION**

TO THE HONORABLE Karl Ory: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the City of Chico, in the state of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Councilmember, in Chico, California, and to demand election of a successor in that office.

The grounds for recall are as follows:

1. Inability to uphold Chico's mission to make Chico a safe place to raise a family, an ideal location for business, and a premier place to live.
2. Not carrying out the will of the people; refusing to prioritize citizens' concerns including public safety, roads in disrepair, housing shortages, and clean parks and waterways.
3. Opposes legislative bill AB430 which would streamline the housing approval process helping Camp Fire victims find quicker housing solutions.
4. Cares more about appeasing his special interest groups and political action committees than the Citizens of Chico and Camp Fire survivors.
5. Out of touch with the concerns of the citizens.
6. Did not meet financial disclosure requirements pertaining to campaign finance and failed to disclose financial interest and adequately describe his conflicts of interest under the Conflict of Interest and Disqualification provision.
7. Was sued by the City of Chico, and is the subject of an ongoing lawsuit costing Chico tax payers hundreds of thousands of dollars in legal fees.
8. Opposes term limits for councilors.
9. Promotes failed homeless solutions that attract and coddle criminals.
10. Inappropriate use of taxpayer dollars.
11. Belittles and disparages constituents during council meetings.



TO THE HONORABLE Randall Stone: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the City of Chico, in the state of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Mayor and Councilmember, in Chico, California, and to demand election of a successor in that office.

The grounds for recall are as follows:

1. Inability to uphold Chico's mission to make Chico a safe place to raise a family, an ideal location for business, and a premier place to live.
2. Demonstrating deceitful behavior by making false statements including claims made at the State of the City Address accusing developers of withholding land and manipulating prices; then refusing to meet with local leaders to work on legislative language (AB430) that would streamline the building process in Butte County helping those affected by the Camp Fire. Not only was Stone unwilling to help Camp Fire victims, he deceitfully planned to undermine AB430.
3. Not carrying out the will of the people and mischaracterizing the Citizens of Chico.
4. Promoting failed homeless solutions that attract and coddle criminals.
5. Refusal to prioritize citizens' concerns including public safety, roadway disrepair, housing shortages, and clean parks and waterways.
6. Frivolous spending of taxpayer dollars on self-serving political stunts.
7. Inability to maintain council decorum.




